



# The Distinguished Professors

How one family optimized their donation to make a difference

### THE BACKGROUND

The Smith family had developed a joy for giving and generosity after partnering with Excellence in Giving. The Smiths would also have the option to opt out of the agreement after five years if the professors left the school or the program ended.

Both Dr. Wood and the Smiths loved the idea. The maximum costs to the Smiths would be \$750,000 versus the \$3 million requested. The Smiths were able to retain their capital.

## THE RESOLUTION

With the help of Excellence in Giving, the Smith family was able to optimize their giving.

Coming from a finance background, Marty Smith knew that endowments grow at a very conservative rate and that his \$3 million wouldn't be optimized the way he knew it could be. Instead, by donating just \$75,000 a year, the Smiths were able to continually see a tangible impact in their investment in the school.
